#### County League Season 2025/2026

Unfortunately Shotford decided not to enter a 'B' team next season, however Lowestoft Rail have entered a second team. The number of teams therefore in the League remains at 29 and the composition of the League remains the same with four divisions – Divisions 1,2 & 3 having 7 teams in each and Division 4 having 8.

The 2025/2026 Season starts on Saturday 4<sup>th</sup> October and the fixtures for the forthcoming season have been sent out to the Clubs with any changes to the fixtures to be sent to the League Secretary by 1<sup>st</sup> October.

## Over 60's Inter Club Double Rink Competition Season 2025/2026

18 Teams have been entered for the 2025/2026 Over 60's Double Rink Competition. Once again the teams have been split into 3 groups with the winners of each group and the best group runner-up qualifying for the Semi-Finals.

The Semi-Finals will be played on a "home" and "away" basis and will be played during the week commencing Monday 23<sup>rd</sup> February 2026, with the winners playing each other in the Final at Dereham IBC on Wednesday 11<sup>th</sup> March 2026 starting at 10.30am.

The fixture schedule has been sent to to the Clubs in order for them to arrange the dates / times of the games and these are again to be sent to the League Secretary by  $\mathbf{1}^{\text{st}}$  October.

## **Competition Secretaries Report (presented by Hon. Assistant Secretary):**

Everything went guite smoothly and the finals have been completed.

Whereas we had a good crowd on the Sunday mainly due to a County Arts player playing in the Under 25 Final all other games the number of spectators was a bit disappointing.

I personally don't think the current format is quite right but don't know the answer to this, with the EIBA introducing more and more competitions with most of March and April being taken up with their Finals.

Also we have lost so many Clubs that used to host these games it would be difficult to host neutral games.

The number of entries in the new Matchplay Singles was also a bit disappointing.

Perhaps the way forward is to run the County Competitions in the same way as the National Competitions.

#### **Match Secretaries Report:**

In the current season we had planned to play 16 fixtures of which 8 were Inter-County Friendlies and 8 were President's Invitation matches.

2 ICF's were cancelled, 1 by us as we were unable to field a team to travel to Northamptonshire in Mid-January and 1 by Cambridgeshire as they could not provide a team to travel to Norfolk BC last December.

Of the 6 matches played we won 3 and lost 3.

It continues to be a problem getting enough players for away fixtures, this means we sometimes have to revert to 5 rinks or triples to enable the fixture to keep going. For the cancelled away at Northamptonshire I only had 14 people interested in going. This is the second time we have cancelled the fixture after they have visited Norfolk and I think we are in danger of losing the fixture if it happens again.

Because the PI games are all played in Norfolk and we are joined by the NCWIBA these are much better supported and we managed to fulfil all of our fixtures.

Of the 8 matches completed, mostly against club teams we have won 2 and lost 6.

I would at this point like to thank Irene Lambert the NCWIBA President for her help in selecting teams for these fixtures.

We will probably have to look for more of these fixtures against Norfolk clubs in the future as it looks as if the ICF fixtures are becoming more and more difficult to fulfil.
